### Breakfast

- A minimum of 1 entree and 2 other items, must be chosen, with a maximum of 1 entree, 3 sides and 1 milk.

### On The Side

A variety of side items and milk are offered to students each day with The Works menu. Students may choose up to three side items offered and one milk selection with their meal entree.

### Charge Policy

The Tuloso-Midway Food Service Department will follow a charge policy of \$5.00 per any student enrolled in the district for meals. Once the maximum limit has been reached, an alternate meal of a sandwich and 8 ounce of milk will be offered to the student as a substitute meal. The District requires that the household be the responsible party for maintaining the positive balance on a student's account.
